**Information for candidates selected in First Round of MDS online MCC counselling for reporting**

M.M. College of Dental Sciences and Research (MMCDSR) is constituent institute of M.M. Deemed to be university. MMCDSR conducts PG Medical Courses – MDS courses. Selection for PG Admissions is based on the rank obtained in the National Eligibility cum Entrance Test (NEET PG-2020).

**1. Admission Process**

Once you have been allocated a seat for a PG Course, through the Centralised Counselling process. **You can report Online or Offline as per directions of DGHS, Government of India and as per directions on website-mcc.nic.in.**

For Offline Reporting, please report to the Committee Hall, Administrative Block, M.M. Deemed to be University to complete the admission process on or before the stipulated date and time mentioned in the seat 'Allotment Letter' issued by the Directorate General of Health Services (DGHS), New Delhi.

- vi. Permanent / provisional Registration Certificate issued by MCI or DCI/State Medical or Dental Council. Provisional Registration Certificate is acceptable only in cases where candidate is undergoing internship and likely to complete the same on or before 31st March of the year of admission.
- vii. High School/Higher Secondary Certificate/Birth Certificate as proof of date or birth.
- viii. Candidates allotted seat must carry one of the identification proofs (ID Proof) to the allotted college at the time of admission (as mentioned in the information Bulletin published by the National Board of Examinations (NBE) for AIPGMEE/ AIPGDEE i.e. PAN Card, Driving License, Voter ID, Passport or Aadhar Card).
- ix. The Candidate should also bring/ upload the following certificates, if applicable.
  - a. SC/ST Certificate issued by the competent authority and should be in English or Hindi language. Sub caste should be clearly mentioned in the certificate.
  - b. OBC certificate issued by the competent authority. The subcaste should tally with the Central List of OBC. The OBC candidates should not belong to Creamy Layer. The OBC certificate must be in the format as mentioned in the prospectus.
  - c. Disability Certificate issued from a duly constituted and authorized Medical Board for 21 Benchmark Disabilities as per the Rights of Persons with Disability Act,2016. No other PwD certificate, issued by any other Authorities/ Hospital will be entertained.

## Rules for counseling

- 1.. The Amount of Fee to be deducted on re-allocation of seat to the candidates in 2nd/3rd round of Counseling : 10000
2. The Amount of Fees To be reimbursed in case Candidate resigns during Counseling period(Rs). : Entire fee after deducting 10000 Rs as processing fee
3. The Amount of Fees To be reimbursed in case Candidate resigns after Counseling period(Rs). : If Seat remains vacant, he she has to pay fee for entire course duration. If seat is filled till last date of counselling then fees will be returned after deducting 10000 Rs as processing fees.
4. Time Period of Reimbursment(in days). : 7 Days
5. Specify Penalty,if any,in case candidate resigns after final round of Counseling : If candidate resigns after counselling period and seat remains vacant, he/she has to pay fee for entire course.
