In accordance to the aforementioned guidelines, and in continuation to the above Institution's Notification, Maharishi Markandeshwar (Deemed to be University), Mullana-Ambala, hereby notifies that:

- 1. The stray vacancy round for MBBS Admission -2022-23 at , Maharishi Markandeshwar (Deemed to be University), Mullana-Ambala, will be conducted as per the Guidelines published Online by the Medical Cancelling committee (MCC), Directorate General of Health Services (DGHS), Government of India.
- 2. The Seat Matrix for the said round is as per the vacant seat matrix available on MCC website.
- 3. Eligibility: Only those candidates whose name is enlisted in 'ELIGIBLE CANDIDATES LIST FOR STRAY VACANCY ROUND' published online by MCC, DGHS are eligible to participate.
- 4. Fee Structure: The Fees Structure is displayed on www.mcc.nic.in.

- 5. Application Forms are available on the University website www.mmumullana.org. The duly filled Application forms along with Cheque/D/D of Rs. 2000/-in name of MMDU, Mullana payable at Mullana with necessary enclosures shall be submitted in person (Offline-Mode), in the University Office latest by 26.12.2022, 09:30 AM. Applications submitted through any other mode will not be accepted under any circumstances.
- 6. Preparation of Merit List: The Inter-se-merit will be prepared on the basis of NEET UG 2022, All India Rank of the eligible applicants.
- 7. Reporting for Admission Process:
 - Venue for Reporting for Admission process: Administrative Block, Maharishi Markandeshwar (Deemed to be University), Mullana-Ambala, Haryana.
 - Date of Counselling :26.12.2022 (10:00 Am onwards)

Please Note:

- 1. Only those candidates who are listed in the DGHS eligible candidates list will be eligible.
- 2. The allotment off seat shall be strictly on the basis of Inter-se-merit of the eligible applicants.
- 3. Physical presence of the candidates, during the prescribed schedule along with all the necessary Original Documents, is mandatory at the time of reporting. Any authorized person in absence of the candidate will not be entertained.
- 4. The candidates who is absent on the prescribed day, date and timing for reporting for admission process, will not be considered for allotment of seat.
- 5. The allotment of seat shall be only after the verification of Original Documents and ascertaining the eligibility for the Candidate.
- 6. The candidates who are selected for admission will have to make the payment of applicable Education fees to the Institution on the spot through Demand Draft/Net Banking. The candidates will also have to secure the payments of fees for balance year by providing undertaking and unconditional bank guarantee/undated cheques in favor of Maharishi Markandeshwar Institute of Medical Sciences & Research, Mullana. For the payable amount which can be redeemed by Institution in the event the fees are not paid by the students and or the student leaves the course mid-stream.
