

NON-DISCLOSURE AND CONFIDENTIALITY AGREEMENT

This Nondisclosure Agreement ("Agreement") is formed between <u>Maharishi</u> <u>Markandeshwar (Deemed to be University) Mullana Ambala</u> ("Recipient/Vendor") and Infosys Limited ("Discloser") to share Confidential Information for the purpose of assessing "<u>information and documents shared by Infosys for enhancing quality of the educational experience of students</u>" ("Purpose").

- 5. The Recipient will use at least the same care, but no less than reasonable care, to avoid disclosure of the Discloser's Confidential Information as it uses with its own Confidential Information and will use the Discloser's Information only for the purpose for which it was disclosed.



- 6. This Agreement will not apply to any information that (i) is or becomes publicly available without breach of this Agreement; (ii) is known by the Recipient without any confidentiality obligation, (iii) is rightfully received from a third party who did not acquire such information by a wrongful or tortuous act; is (iv) is independently developed by the Recipient or (vi) is authorized by the Discloser for release.
- 7. If a governmental entity or legal authority requires the Recipient to disclose Confidential Information, the Recipient will give the Discloser prompt written notice sufficient to allow the Discloser to seek a protective order. The Recipient will also use reasonable efforts to obtain confidential treatment for any such Confidential Information.
- 8. No rights are granted to use the Confidential Information except for the express limited rights stated in this Agreement. The Confidential Information remains the exclusive property of the Discloser.
- 9. This Agreement shall be governed by the laws of India, and both parties further consent to jurisdiction by the courts in Bangalore, India.
- 10. Discloser may terminate this Agreement by providing thirty (30) days written notice to the Recipient. Any terms of this Agreement, which by their nature extend beyond its termination remain in effect until fulfilled, and apply to respective successors and assignees.

(Google and the University are hereinafter collectively referred to as "Parties" and individually as "Party" unless the context requires otherwise.)

INTRODUCTION

- A. University wishes to implement technical solutions and educational digital literacy initiatives and programs.
- B. Google wishes to promote and support education and digital literacy in University's region.
- C. The parties have agreed to collaborate in accordance with the terms and conditions of this Agreement.

1 University Programs

APPLICABLE LAWS & ANTI-BRIBERY

- 3.1 University represents and warrants that it will comply with all applicable laws and regulations, including all applicable commercial and public anti-bribery laws ("Anti-Bribery Laws") such as the U.S. Foreign Corrupt Practices Act of 1977 and the UK Bribery Act of 2010, which prohibit corrupt offers of anything of value, either directly or indirectly, to a government official to obtain or keep business or to secure any other improper commercial advantage. "Government officials" include any government employee; candidate for public office; and employee of government-owned or government-controlled companies, public international organizations, and political parties.

"Background IP"means all Intellectual Property owned or licensed by a party (a) before the Effective Date of this Agreement; or (b) independent of this Agreement.
- 5.2 Except for the any license rights which might be specifically granted hereunder, neither party will own or acquire any right, title, or interest to the other party's Background IP under this Agreement. All Intellectual Property Rights comprised, subsisting or developed in conjunction with or as a result of a Google Solution (including without limitation, any materials, documents, data, hardware and software provided by Google) shall vest in and belong absolutely to Google.
- 5.3 Without limitation, any use by University of Google's Trademarks (whether in relation to the Program or otherwise), is subject to Google's prior written consent. C. The Parties have certain mutual interests and are coming together to discuss, test and evaluate a potential business relationship, in accordance with the terms and conditions contained in this MoU.

NOW IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. Purpose

- 1.1. The Parties would like to have a business relationship of mutual interest, wherein UpGrad shall approach students of the University ("Students") and market UpGrad's Programs (as defined later). The Parties shall carry out the on and off campus marketing activities to ensure that at least 120 (One hundred twenty) Students register for UpGrad Program scheduled January 2019 and July 2019 batches and such number for the ensuing UpGrad Programs' cohort as mutually agreed by both the Parties.
- 1.2. The Parties shall promote various programs developed and offered by UpGrad ("UpGrad Programs") which are listed in Annexure A to the Students by conducting various on and off campus activities.
- 1.3. University's obligations shall be as follows:
 - 1.3.1. to assist UpGrad in marketing activities of UpGrad's Program to Students;
 - 1.3.2. shall direct all queries made by Students and any complaints directly to UpGrad;
 - 1.3.3. ensure that all staff employed by the University for the purpose of conducting the activities under this MoU have undergone the requisite training with UpGrad. UpGrad may require such staff to undergo refresher trainings at suitable intervals. The costs for the actual training shall be borne by UpGrad;
 - 1.3.4. shall allow UpGrad right to use University's name and logo on the UpGrad educational platform, website, on marketing material and on promotional material;
 - 1.3.5. shall assist in all possible ways to get the documentation signed from the Students as per the format designed by UpGrad.
- 1.4. UpGrad's obligations shall be as follows:
 - 1.4.1.provide training support for the staff employed by the University for the activities to be conducted under this MoU;
 - 1.4.2. provide certain pre-decided marketing collaterals to the University for distribution to the Students; and
 - 1.4.3. appropriately deal with all queries and complaints raised by the Students that have been directed to UpGrad.
- 1.5. Neither Party shall be obligated to offer any business opportunities or to conduct business exclusively with the other Party by virtue of this MoU.

2. <u>Intellectual Property</u>

2.1. "Intellectual Property Rights" means all rights worldwide in, to and under copyrights, copyright

registrations and applications, trademarks (including trade dress, service marks and trade names), trademark registrations and applications, domain names, patent, patent applications (including the right to claim priority under applicable international conventions) and all patents issuing thereon, inventions, whether or not patentable, trade secrets, author rights, moral rights, rights in goodwill, and other proprietary rights, as may exist now and hereafter come into existence, and all renewals and extensions thereof.

- 2.2. Each Party and its licensors are the sole owners of and shall retain in perpetuity, all the Intellectual Property Rights to the content and educational material provided by it as a part of its services to the Student, and the other Party shall not make any claim towards the same.
- 2.3. Nothing in this MoU shall be construed as granting any Intellectual Property Rights of either Party, nor shall this MoU grant either Party any rights in or to the other Party's Confidential Information other than the limited right to review such Confidential Information solely for the purpose of conducting activities under this MOU.

3. Representation & Warranties:

- 3.1. Each Party represents and warrants to the other that:
- (a) It has the legal right, power and authority to enter into this MoU and perform all of its obligations, terms and conditions hereunder; and
- (b) neither the execution nor delivery of this MoU, nor the fulfillment nor compliance with the terms and provisions hereof, will conflict with, or result in a breach of terms, conditions or provisions of, or constitute a default under, or result in any violation of any agreement, restrictions, instrument, order, judgment, decree, statute, law, rule or regulation to which he is subject, or require any consent, approval or other action by any court, tribunal, administrative or governmental or private body.

4. Confidential Information

- 4.1. Either Party will not disclose any proprietary information that is provided to it by the other Party under this MoU or which that Party may have access to pursuant to this MoU. Such information may include, policies, internal workings of Parties, data, other proprietary information of either Party including but not limited to the trade practices, strategies, or product development plans of either Party ("Confidential Information"). Each Party agrees to prevent unauthorised access to or dissemination of the Confidential Information of the other Party. Each Party acknowledges and agrees that it shall be responsible to ensure its employees' adherence to the confidential obligations set forth in this clause. However, this restriction does not apply to information which: (a) either Party independently developed without reference to or use of the Confidential Information of the other Party; (b) is in public domain without breach of the confidentiality obligation or made public by any Party; (c) is disclosed with the other Party's prior written approval; or (d) is revealed pursuant to court or regulatory order or mandatory process of law, provided the Party gave as much advance written notice to the other Party as possible (to the extent not prohibited by law) regarding the disclosure.
- 4.2. The provisions of this Clause 4 shall remain valid for a period of two (2) years post the termination or expiry of this MoU.

5. Limitation of Liability

This MoU sets forth the full extent of the Parties obligations and liabilities arising out of or in connection with this MoU, and there are no conditions, warranties, representations or terms, express or implied, that are binding on the Parties, except as specifically stated in this MoU. Any condition, warranty, representation or other term which might otherwise be implied into or incorporated in this MoU, whether by statute, common law or otherwise, is hereby expressly excluded.

6. Indemnity

Each Party shall indemnify, defend and holds harmless the other Party and its respective affiliates, officers, directors, employees, agents, successors, assigns and representatives, from and against any costs, losses, damages, liabilities, judgments and expenses (including reasonable fees of attorneys and other professionals), arising out of or in connection to any claim, action or proceeding which in any way may result from or arise in any manner out of a breach of its obligations under this MoU or towards the Customer.

7. Term & Termination

- 7.1. This MoU shall commence on the Effective Date and shall be valid for the period of two (2) years ("<u>Term</u>"), unless terminated as per the terms of this MoU.
- 7.2. Either Party may terminate this MoU with or without cause, by providing the other Party with prior notice of fourteen (14) days. In the event of such termination, all payments due to either Party shall be paid by the other Party up to the date of termination.

8. Miscellaneous

This MoU constitutes the entire agreement between the Parties, as to the subject matter hereof, superseding all previous communications and negotiations, whether written or oral. All additions, modifications, supplements and amendments to this MoU must be made in writing and must be signed by both parties before they shall be effective. Unless otherwise provided in writing, the failure of either Party to insist upon or to enforce strict performance by the other Party of any of the provisions of this MoU or to exercise any right under this MoU shall not be construed as a waiver or relinquishment of its right to assert or rely upon any provisions or right in that or any other instance; rather, the provisions and right shall remain in full force and effect. No waiver shall be effective unless in writing signed by the person or entity charged with making such waiver.
